South via I-59 (Southwest Freeway)	Take Downtown exit/Exit on Travis/Turn right on Preston/Turn left on San Jacinto and left on Congress
East via I-10 (East Freeway)	Exit San Jacinto which will become Fannin/Turn right on Congress
West via I-10 (Katy Freeway)	Take the Downtown/Smith exit/Turn left on Preston/Turn left on San Jacinto and left on Congress
