Creator Sketch:

Jon Stephen Lindsay was born on December 4, 1934, in Santa Fe, New Mexico. He graduated from New Mexico State University, with a Bachelor of Science degree in Civil Engineering. An Air Force veteran who served as an officer at James Connally AFB in Waco, Texas from 1959 to 1962, Lindsay moved to Houston in 1962 and formed his own construction company.

In 1974 Lindsay successfully ran against incumbent Bill Elliot for the office of Harris County Judge and served from 1975 to 1994. Lindsay initiated many projects during his administration including the construction of the Harris County Toll Road system, park development, flood control projects, construction of jail and juvenile detention facilities, and the establishment of a joint state and county psychiatric facility. In 1986, the Texas Society of Professional Engineers recognized Judge Lindsay as "Engineer of the Year" for his foresight and leadership of the construction of the Sam Houston and Hardy Toll Roads.

Lindsay was elected to the Texas Senate in 1996, representing the 7th Senatorial District, which consists of the northern portion of Harris County. While serving in the senate, he served on several legislative committees including Intergovernmental Relations (1997-2002, 2005-2006; vice-chair, 1999-2002), Natural Resources (1997-1998, 2003-2006), Health and Human Services (1999-2000, 2003-2006), and Nominations (2001-2004; chair, 2003-2004). Lindsay chose not to run for re-election in 2006.

Lindsay is married to Tony Lindsay, Judge of the 280th Civil District bench.
