1901 - 1994

At least two Justices of the Peace worked concurrently as Precinct 1 JPs as early as the 1880s and possibly earlier. Acknowledging the different places occurred much later. Therefore, it is possible that early Precinct 1-2 records are attributed to the Precinct 1 Justice of the Peace.
