1870 - 1997

Many of the records that are attributed to Precinct 1 may in reality have been Precinct 1-2 records. At least two Justices of the Peace worked concurrently as Precinct 1 JPs as early as the 1880s and possibly earlier. Therefore, there are several dockets covering the same chronological period.
